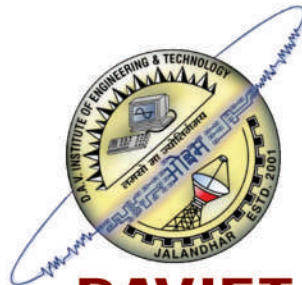

This Memorandum of Understanding is executed by **Mr. Sandeep Soni** on behalf of the Dream Weavers Edutrack Pvt Ltd. and **Dr. Manoj Kumar** on behalf of DAV Institute of Engineering & Technology.

PURPOSE: This MOU is to provide the hands on Training and Skill development for the students of B.Tech/MCA/Vocational Courses from within and outside the campus premises.

Dream Weavers Edutrack Pvt Ltd. shall: Provide the training on the course and curriculum designed by the Dream Weavers Edutrack Pvt Ltd., through one of its Vertical "Dream Tech Lab" who shall also establish the Lab in Centre of Excellence (detailed document/ annexures) for the students and the content(s) will not be used elsewhere by the DAV Institute of Engineering & Technology. The courses, as discussed, shall be adhered to its completion including Project(s) if any, to maintain the quality aspect, for cause of the students. The course/ fee of the courses will be decided as per market demand and mutual discussions.

It is mutually understood and agreed upon by and between the parties that:

1. SHARE:

Dream Weavers Edutrack Pvt Ltd will have the 70% share and DAV Institute of Engineering & Technology will have the 30% share from the revenue/collection after deducting the service tax.



2. **MODIFICATION:**

Modification to this MOU can be done by the mutual consent of both the parties, by the issuance of the written modification, signed and dated by the authorized Officials, prior any changes are performed.

3. **PARTICIPATION IN SIMILAR AND OTHER BUSINESS ACTIVITIES:**

This agreement is completely exclusive and restricts both the parties from participating in similar activities with other public/private agency (ies) in the same premises, for the prescribed courses.

4. **TERMINATION:**

This MOU will be valid for a period of minimum three years subject to renewal thereafter, as mutually agreed upon and given consent by both the parties on expiry of three years; it can be mutually recalled back and cancelled prior to three years if need so arises with 6 months prior notice; on revised terms and conditions, if any suggested/advised for mutual growth and development-cause of the students.

5. **PRINCIPAL CONTACTS:**

This MOU shall be executed by Mr. Sandeep Soni (MD) Dream Weavers Edu Track Pvt. Limited and Dr. Manoj Kumar (Principal) and or if otherwise by the competent authority.

9. **LIABILITIES:**




This Memorandum of Understanding is made on 6th day of June 2017 between the **DAV INSTITUTE OF ENGINEERING AND TECHNOLOGY, JALANDHAR**, having its office at Kabir Nagar, JALANDHAR hereinafter referred to as **DAVIET** which expression shall mean and include its successors in interest and assigns and represented by its representatives.


AND

The **CENTRE FOR DEVELOPMENT OF ADVANCED COMPUTING, MOHALI**, a scientific society of the Ministry of Communications and Information Technology, Government of India, established in 1988, having its office at A-34, Phase-V||, Industrial Area, Mohali (Near Chandigarh) - 160071, hereinafter referred to as **C-DAC** which expression shall mean and include its successor-in office and assigns and represented by its representatives.

BACKGROUND

WHEREAS, DAVIET through its qualified faculty and well equipped laboratories, state of art computer facilities and independent broad band internet connectivity provide ample scope for students to learn round the clock. The institute offers B.Tech, M. Tech, MCA and MBA in different streams of Engineering and Technology (Electronics and Communication Engineering, Computer Science and engineering, Electrical Engineering, Information Technology, Mechanical and Civil Engineering.) Facilities to pursue research in these core areas are also available in the institute.

AND WHEREAS, C-DAC is primarily an R&D institution involved in the design, development and deployment of world class electronic and IT solutions for economic and human advancements. It caters to the training, consultancy, design and product development needs of the Electronics and Information Technology industry and its allied sectors. The major thrust areas of the Centre in training and R&D are: Multilingual and Heritage Computing, Professional Electronics including VLSI and Embedded Systems, Software Technologies including Open Source software, Cyber Security and Cyber Forensics, Health Informatics including Medical Electronics, PCB Design and Manufacturing, Ubiquitous computing. It also offers M.E programmes in VLSI Design, Electronic Product Design and Technology (EPDT), Embedded Systems and IT (part-time). C-DAC has successfully developed telemedicine network along with various software solutions for health care, it acts as a Resource Centre for Cyber Security and RFID based Systems and has many successful electronic products to its credit.



At present many academic/research activities are going on in DAVIET in the area of Cyber Security, VLSI Design and embedded systems, Software solutions and technologies, Bio-medical Image Processing, Content Based Medical Image Retrieval, Software Technologies and other related Bio-Science/Engineering topics. These areas are overlapping with corresponding areas of interest in C-DAC. For further impetus to such inter-disciplinary areas, some collaborative activities need be encouraged and initiated. Such partnership will help the ongoing research, enhance human resource and provide a wider exposure to students at both the institutions. Accordingly, this MOU will facilitate mutual cooperation and help us to make meaningful research and project proposals for future funding.

OBJECTIVES

In witnessth of the aforesaid, both DAVIET and C-DAC, Mohali

1. Recognizing the importance of research and development in the areas of Biomedical Science, Engineering and Technology, Software Technologies, Energy, Electronics and Cyber Security.
2. Appreciating the need for integrating the reservoir of highly qualified manpower in the fields of expertise at both institutes.
3. Desiring to amalgamate their efforts by pooling their expertise and resources.

Now agree upon, to form a nucleus for promoting Research & Development and creation of human capital in the fields of Biomedical, Electronics, Cyber Security, Software Engineering and allied areas by exploiting the unique expertise, intellectual and infrastructural capabilities of both the parties.

SCOPE AND GENERAL ACTIVITIES

Further, in witnessth of the above both the parties to this MoU shall collaborate on research projects and frame joint proposals for submission to the funding agencies.

1. Shall exchange of research documents/findings on a case to case basis.
2. Provide for joint supervision of PhD Scholars (in case of a Research Project) as per the University rules governing the same.
3. Plan and organize joint conferences/ workshops/Seminars etc.
4. Share laboratory, library and such other resources for the research teams on availability for bilateral applications without any financial burden on either party.
5. Make available research facilities to each other's registered research scholars. To utilize these facilities the research scholars would be considered at par with the research scholars of either of the organization/university.



Further:

- i) Any other activity may be included with mutual consent. To nominate Coordinators as nodal contacts to represent the parties and promote interface so as to plan, implement, monitor, review the various activity schedules from time to time.
- ii) All attempts will be made to ensure that developments and projects are accomplished to a very high degree of quality, with parsimony of time.
- iii) To promote the Exchange of technical staff, research scholars, Faculty, post doctoral fellows & students (including internship).
- iv) The collaborative programme between two parties shall be coordinated by a Coordination committee consisting of one member from each organization.
- v) Research scholars can fulfill the residency requirements from either of the organization/university.
- vi) Visits of faculty, staff and students to each other's campus (during visits, faculty/staff students would be provide appropriate accommodation in hostel/guest houses as per availability)
- vii) Agreement will be made for specific projects separately.

FINANCIAL TERMS

There is no direct financial obligation on either Institute unless specifically agreed to. The financial requirement of individual institutions for joint project proposals will be separately mentioned in joint projects while submitting to funding agencies.

DURATION

This agreement shall come into effect on the day of the approval by both institutes with an initial duration of five years, which would be revised further for another term of 5 years based on mutual consent.

TERMINATION

Either institute may terminate this agreement provided that a written notice to this intent is given to the other Institute at least six months prior to the termination.

INTELLECTUAL PROPERTY RIGHT (IPR)

Rights regarding publications, patents, royalty, ownership of software, design, product developed, etc. under the scope of this MOU, shall be decided by the two parties by mutual consent. Intellectual Properties, which are in possession of C-DAC prior to this agreement or to be acquired outside the collaborative project with DAVIET, will remain the exclusive property of C-DAC. Intellectual Properties which are in possession of DAVIET prior to this agreement or to be acquired outside the collaborative project with C-DAC will remain the exclusive property of DAV IET. Intellectual Property/ies that may come about in the course of execution of collaborative project(s) between C—DAC and DAVIET will be the joint property of C-DAC and DAVIET unless otherwise mentioned clearly in project proposals or project specific agreements.

All the expenses towards filing, prosecution and maintenance shall be equally shared.



CONFIDENTIALITY

- a) During the Term of MOU, either party may provide to the other proprietary and confidential information that it considers essential for the conduct of any PROJECT at their sole discretion.
- b) PROPRIETARY INFORMATION for the purposes of this AGREEMENT shall include all data, samples discoveries, inventions, technical information, reports, known-how and other information related to and disclosed by either party to the other in any form of written material and it shall be the duty of the receiving party to maintain its confidentiality.
- c) The DAVIET and C-DAC agree to hold PROPRIETARY INFORMATION in confidence and to protect it against disclosure to the public and third parties. Accordingly both DAVIET and C-DAC shall employ protective measures fully commensurate with those used by them to protect their own trade secrets and other confidential information from disclosure to the public and to third parties, but in no event less than ordinary degree of care required by law to preserve the secrecy of information that under such law is deemed confidential. By way of example, such efforts will include the act of obtaining the execution of suitable confidentiality agreements from other parties and from other persons to whom such information is disclosed in the course of execution of the PROJECT and to retrieve the connected documents on completion of the project where given for the same.
- d) The DAVIET and C-DAC agree to use PROPRIETARY INFORMATION only for the specific project during the term of such project.
- e) The DAVIET and C-DAC agree not to copy, reproduce or otherwise reduce to writing any Part of PROPRIETARY INFORMATION except and only as may be reasonably necessary for the PROJECT.
- f) INFORMATION disclosed by either party to the other in the form of result of the study/research originating from the projects under the agreement shall be treated as confidential and should not be shared with any third party, including and country, without the expressed permission of giving party.
- g) Both DAVIET and C-DAC will be free to publish research results out of projects under this agreement that does not contain proprietary information. In case it contains proprietary information decision to publish will be on a mutual consent basis so as to ensure protection of the related intellectual property.
- h) The non-disclosure clause will survive five years from the date expiry of this MOU.

Memorandum of Understanding

This Memorandum of Understanding is made on 23-APR-2019

Between:

1. **DAV Institute of Engineering & Technology**, an Institution / college incorporated and existing under the laws of India, having its registered campus at **DAVIET, Kabir Nagar, Jalandhar, Punjab – 144008 (“DAVIET”)**;

AND

2. **Huawei Telecommunications (India) Co Pvt. Ltd.**, a company incorporated and existing under the laws of India and having its registered office at 7th Floor, Tower-A, Spaze I-Tech Park, Sohna Road, Sector – 49, Gurgaon – 122001, Haryana, India (“**Huawei India**”)

Each party is referred to in this Memorandum of Understanding as a “**Party**” and collectively as the “**Parties**”.

Recitals:

1. Whereas Institution desires to be appointed as ICT Academy of Huawei.
2. Huawei is considering the appointment of Institution as ICT Academy of Huawei.

The Parties agree as follows:

1. Objective

- 1.1 The Parties further to their discussion intends on the possibility of forming a cooperative relationship for the appointment of Institution as ICT Academy of Huawei. In order to facilitate this intention, the Institution has agreed to enter into the agreement (Annexure 1) with Huawei Technologies Co., Ltd. having its registered office at Huawei industrial Base, Bantian, Longang District, Shenzhen, P.R. China, and this agreement is under signature.
- 1.2 This Memorandum of Understanding is being signed between the parties to authorize the Institution to start the training batch for their students immediately and also assist the Institute to get support from Huawei India for registering under ICT Academy of Huawei as per the terms and conditions agreed in the agreement.

2. Non-binding nature

- 1.3 The Parties agree that this Memorandum of Understanding, continuing discussion, future exchange of information, past or future correspondence or other communications between the Parties shall not commit either Party to continue discussion or negotiation nor shall such

be legally binding as an informal agreement or agreement to agree to a potential cooperative relationship. The only way the Parties shall be bound to a cooperative relationship, if at all, shall be by a definitive agreement in writing duly executed by the Parties. Any other action or expenses which either Party takes or incurs in anticipation that a cooperative relationship will be consummated shall be entirely at that Party's risk and expense and shall not impose any liability on the other Party.

- 1.4 This Memorandum of Understanding describes the intention of the Parties and is not intended to be (nor shall it be deemed to be) a legally binding contract or to have any legally binding effect on the Parties or create any legal rights or obligations, with the exception of Clauses 2 to 10 which shall be binding contractual terms between the Parties.

3. Scope of MoU

- 3.1 Institution has shown interest to start the ICT Academy courses in the field of Routing & Switching (HCNA- R&S)
- 3.2 Institution has agreed to start the first batch from **June 2019**.
- 3.3 Institution shall embed the ICT Academy of Huawei courses in their regular curriculum as mandatory or elective courses.
- 3.1 Institution shall prepare the training environments and equipment and/or simulator to meet the experimental requirements of Huawei's training programs and only after such preparation is ready, will Huawei grant the certificate and the nameplate to ICT Academy of Huawei for Huawei Certified Training Programs.
- 3.2 Institution shall get at least two of their instructors certified by Huawei for certification for each course or use the services of an already certified instructor in order to be able to impart the ICT Academy of Huawei course education to its students before starting the ICT Academy Class as mentioned in clause 3.2 above.
- 3.3 Institution promises to run one batch of minimum 50 students every year and ensure 30 Huawei Global Exam certification.
- 3.4 Huawei shall grant usage of ICT Academy of Huawei logo to the Institution.
- 3.5 Huawei will provide electronic copy of Training Kit and authorize ICT Academy of Huawei to print the Training Kit for training courses;
- 3.6 Huawei shall provide simulators and free access to Huawei's e-learning content to enrolled students under Huawei ICT Academy program.
- 3.7 For Test Voucher, ICT Academy of Huawei shall purchase from Huawei nominated company.
- 3.8 Subsequently Huawei shall offer a 50% discount codes on its voucher price for every student. This Policy may be updated from time to time.
- 3.9 Huawei shall provide Training participation certificate to all enrolled students who



complete the course.

- 3.10 Huawei shall facilitate in internship for students undergoing ICT Academy of Huawei courses.
- 3.11 Huawei shall facilitate placement support to only those students who attain Huawei Global certification.

4. No publicity without mutual consent

- 4.1 Neither Party shall undertake any promotion, advertising or propaganda relating to this Memorandum of Understanding or the subject matter of this Memorandum of Understanding without prior written consent of the other Party.

5. Term and Termination

- 5.1 This Memorandum of Understanding shall continue in force until the first to occur of the following events ("Term"):
 - (a) the expiration of Twelve (12) months from the date of this Memorandum of Understanding;
 - (b) either party shall be entitled to terminate this Memorandum of Understanding upon three-month prior written notice to the other Party;
 - (c) either party committing a material breach of the provisions of this Memorandum of Understanding in which event the other Party shall be entitled forthwith to terminate this Memorandum of Understanding by written notice to the Party in breach;
 - (d) Either Party shall be entitled forthwith to terminate this Memorandum of Understanding upon written notice in the event that the other Party has ceased or threatened to cease business or is or has been wound up.

6. Parties not partners

- 6.1 Nothing in this Memorandum of Undertaking shall constitute a partnership between the Parties. Except as set out in this Memorandum of Understanding, neither Party shall have express or implied authority to bind or represent the other Party for any purpose whatsoever unless expressly agreed in writing by the Party concerned.

7. Assignment

- 7.1 Neither Party shall assign or transfer its rights or obligations under this Memorandum of Understanding.



8. Confidential Information

- 8.1 Each Party acknowledges that it is in a confidential relationship with the other Party. Each Party also acknowledges that during the term of this Memorandum of Understanding, it may have access to privileged information deemed to be secret and confidential and which constitutes the exclusive property, trade secrets and confidential information of the other Party or one of such other Party's affiliates (collectively "Confidential Information").
- 8.2 Confidential Information shall be used by the recipient only in connection with the provision of this Memorandum of Understanding and shall not be used for other purposes.
- 8.3 Each party shall maintain the confidentiality of the Confidential Information and to use the same degree of care as it uses with regard to its own Confidential Information to prevent the disclosure, publications or unauthorized use of the Confidential Information. Neither Party may duplicate or copy Confidential Information of the other Party other than to the extent reasonably necessary for legitimate business uses in connection with this Memorandum of Understanding.

9. Severability

Subject to clause 2, if any provision of this Memorandum of Understanding is declared void, illegal, unenforceable or in conflict with any law of a state or government having jurisdiction over this Memorandum of Understanding, the validity or enforceability of the remaining provisions shall not be affected thereby.

10. Notices

All notices and other communications under or in connection with this Memorandum of Understanding shall be in writing and shall be deemed to have been duly given: when delivered, if delivered by messenger during normal business hours of the recipient (and a signature from an authorized recipient is obtained); when sent, if transmitted by facsimile transmission (electronic transmission report confirmed) during normal business hours of the recipient; or on the third business day following mailing, if mailed by certified or registered mail, postage prepaid; in each of the above cases to the address set out in this Memorandum of Understanding or fax number as may be notified by one Party to the other Party from time to time.

11. Applicable law





And

DAV Institute of Engineering and Technology, Kabir Nagar, Jalandhar -144008, Punjab, India (hereinafter referred to as "DAVIET", which expression shall unless repugnant to the context and meaning thereof mean and include its successors, administrators, authorized representatives and permitted assigns). (HET and DAVIET shall hereinafter be collectively referred to as the "Parties" and individually referred to as "Party" in this MOU)

WHEREAS:

- i) **HET** is a public charitable trust registered under the Indian Trust Act, 1882 *inter alia* with an objective to impart Heartfulness approach to various wellness programmes including relaxation, meditation, values based educational programmes for schools, colleges, government organizations, corporates etc., made available to all who are willingly interested in individual development and wellbeing. NOW THEREFORE, THE PARTIES HEREBY AGREE AS UNDER:

1. PURPOSE AND OBJECTIVES

- 1.1. **DAVIET** desires to create a precedent by offering suitable and pertinent learning and offerings to its students so as to enable them to lead their lives with purpose and be of help to the society at large. **DAVIET** has represented that it is a leading educational institute that offers high quality education and its priority is to provide its students values, inner development enabling them to perform better in their education & be leaders in nation building. 4. OTHER OBLIGATIONS OF DAVIET

- 4.1. **DAVIET** shall extensively promote **HET** Offerings so that greater populace of students in **DAVIET** shall benefit from this initiative. As previously indicated in Clause 1.1 above, being a value-based

model of education, **DAVIET** may make all or any part of the Offerings, as applicable, a part of their curriculum for the students on a mutually agreed basis between the Parties.

However, it is hereby agreed that certain expenses relating to but not limited training programs, workshops and faculty shall be on a charged in the following manner. **DAVIET** shall bear the expenses:

TERM

5.3. This MOU has been executed for the purpose of organizing workshops/ seminars/ training sessions at the premises of **DAVIET** or such other premises as may be mutually agreed upon in writing.

- 5.4. This MOU shall come into effect from the Execution Date and shall remain in force for a period of five years thereafter.
- 5.5. This MOU shall terminate after completion of the **term of five years** from the Execution Date, without any financial obligations of Parties, except for any pending reimbursements and costs as provided herein.
- 5.6. The Parties may execute similar agreements for similar initiatives in future or even extend the term of this MOU for such further periods as mutually agreed to by the Parties.
- 5.7. Either Party may voluntarily terminate this MOU by giving a 3 months' notice in writing to the other.
- 5.8. The provisions of this Clause 6.6 and 8 and all of its sub-clauses will survive any expiration or termination of this MOU.

6. ASSIGNMENT

This MOU is personal to the Parties and the rights and obligations established herein shall not be assignable by the Parties, except to the extent expressly permitted under this MOU or with the prior written consent of the other Party.

- 7.2. All intellectual property rights including all (i) copyrights and other rights associated with works of authorship throughout the world, including neighboring rights, moral rights, and mask works, (ii) trade secrets and other confidential information, (iii) patents, patent disclosures and all rights in inventions (whether patentable or not), (iv) trademarks, trade names, internet domain names, and registrations and applications for the registration thereof together with all of the goodwill associated therewith, (v) all other intellectual and industrial property rights of every kind and nature throughout the world and however designated, whether arising by operation of law, contract, license, or otherwise, and (vi) all registrations, applications, renewals, extensions, continuations, divisions, or reissues thereof now or hereafter in effect ("**IPR**") with respect to (a) "Heartfulness", (b) "Heartfulness Relaxation", (c) "Heartfulness Meditation", (d) "Heartfulness Cleaning", their techniques and/or connected procedures therein and (d) the title and content/modules or any other information shared with DAVIET, it's staff, students and teachers, as the case may be, as part of the Offerings of HET, and (e) other trademarks belonging to HET or of those of its associates, (collectively referred to as "**Heartfulness IP**") as and when used by HET under license shall always vest with HET or its associates, as applicable. HET reserves the right to use

the same internally or externally at its sole discretion.

- 7.3. This MOU in no way creates or conveys any ownership interests in Heartfulness IP to **DAVIET**. **DAVIET** shall only use such Heartfulness IP or any part thereof, in the manner and form previously approved in writing by **HET** and in coordination with and assistance of **HET** authorized representatives.
- 7.4. **HET** reserves the right to modify, change or improve such Heartfulness IP in the manner it deems fit and implement such changed versions of Heartfulness IP or wellness techniques at anytime during the term of this MOU.
- 7.5. The Parties agrees that all ownership rights in any and all testimonials submitted in accordance with Clause 4.2 (iv) above shall vest with **HET**.

8. INDEMNITY

- 8.1. Except for cost reimbursements, the services provided by **HET's** with respect to the Offerings are on a mutual basis and free of cost. Only willing participants for their own wellbeing / self-development are required to participate. **DAVIET** may for development of its students make the **HET** programs, modules and/or workshops as part of its curriculum. The Parties, therefore, agree that such services do not give rise to any kind of damage or liability to anybody who participates and therefore no damage can arise there from. No indemnity is therefore provided herein. The Parties agree that that **HET** programs do not guarantee success of its objectives or purposes as mentioned anywhere in this MOU.
- 8.2. In the event **DAVIET** breaches the terms of Clause 8 (intellectual property) of this MOU, **HET** shall be entitled to seek specific performance against the **DAVIET** for performance of its obligations under Clause 8 (intellectual property) of this MOU in addition to any and all other legal or equitable remedies available to it.

9. GOVERNING LAW, JURISDICTION & ARBITRATION

- 9.1. This MOU shall be construed, interpreted and enforced in accordance with laws of India. In case of any differences between the Parties, they shall make all efforts to settle the disputes amicably through mutual discussion and negotiation within 30 days, failing which, dispute(s) shall be referred to a sole arbitrator appointed by both the Parties, as per provisions of Arbitration and Conciliation Act, 1996. Language of arbitration shall be English and place of arbitration shall be [Jalandhar, Punjab].
- 9.2. Subject to the arbitration Clause 10.1 above, the courts of competent jurisdiction at [Jalandhar] shall have exclusive jurisdiction with respect to any and all matters pertaining to this MOU.



SCHEDULE- 1
Scope of Work

Heartfulness Education Trust (HET) shall offer the following programs specifically developed for specific needs of the University:
